The Egyptian Citizenship by Investment Unit manages all applications, and the program works in accordance with Parliament Law No. 190 of 2019. Egypt's Citizenship by Investment program is one of the world's most recent, offering a wide range of investment options, from donations to property purchases and business acquisitions. The full process normally takes about 6-9 months. However, the Egyptian passport currently grants visa-free access to only 51 places, limiting most applicants' travel options.

Eligibility

- You must be at least 18 years old.
- Must have a clean criminal record.
- Must pass a thorough background check
- A medical examination confirms that you are in good health.
- Must meet the required investment criteria and have no negative immigration history in Egypt.

Key Benefits

- Egyptian citizens can apply for a US E-2 visa through setting up or buying a business.
- Egypt has nine public free zones where enterprises can receive complete corporate tax exemptions.
- Investors may include their spouse and children up to the age of 21 in the application.
- Egypt's location between Africa, Europe, and the Middle East provides significant commercial and investment prospects.



Investment Options

1. Real Estate Investment.

Investors can buy one or more properties for a minimum investment of USD 300,000. The amount can be paid in installments over a year.

2. Company Establishment

Applicants must invest at least USD 350,000 by starting a new business or investing in an existing one, plus make an additional USD 100,000 contribution to the state.

3. Donate

Egypt grants citizenship for a non-refundable USD 250,000 Central Bank deposit, payable within one year, with approval after full payment.

4. Bank deposit.

Applicants can make a refundable USD 500,000 deposit with Egypt's Central Bank, returned after 3 years without interest.

Process

- 1 XIPHIAS evaluates your profile and suggests the optimal investment option.
- 2 XIPHIAS helps prepare all required documents, including passports, birth certificates, photos, police and medical certificates, and fee confirmations.
- 3 A two-stage background check confirms the investor's identification.
- 4 Following first clearance, a six-month temporary residence permit is granted. Investors must travel to Egypt to complete their investment requirements.
- 5 After meeting the investment conditions, the Citizenship Department conducts a final evaluation.
- 6 Once authorized, the investor is issued a naturalization certificate and an Egyptian passport.
