## Investment Options

### 1. Real Estate Investment.

- Investors can purchase one or more properties in Greece for a minimum investment of €250,000. The property must be in a qualifying area and can be residential or commercial. Ownership of the property grants a renewable 5-year residency permit for the applicant and family members.

### 2. Capital Investment

- Applicants can make a capital investment ranging from €250,000 to €800,000 in approved Greek financial instruments such as startups, venture funds, government bonds, or deposit schemes. Proof of funds transfer to Greece and compliance with local financial regulations are required. Residency is granted for 5 years, renewable as long as the investment is maintained.

## Process

- 1 Preliminary Setup:** Choose property, complete KYC, sign POA, get Greek tax number.
- 2 Investment & Documentation:** Choose property, complete KYC, sign POA, get Greek tax number.
- 3 Application & Biometrics:** File Golden Visa application, provide biometrics.
- 4 Approval & Aftercare:** Get approval, receive post-landing support.
- 5 Permanent Residency Status:** Enjoy EU residency rights, maintain investment.
