## About Hong Kong RBI

Hong Kong relaunched its Capital Investment Entrant Scheme to attract global investors seeking stability and residency. By investing HKD 30 million in eligible assets, investors and families can secure residency, with eligibility for Permanent Residency after 7 years. With strategic location, strong infrastructure, transparent laws, and competitive taxes, Hong Kong remains a top investor residency destination.

## Eligibility

- Minimum HKD 30 Million investment
- You have no criminal history
- You have a private health insurance policy
- Proof of the legitimate source of funds

## Investment Options

### 1. Capital Investment Entrant Scheme (CIES)

- Invest HKD 30M (~USD 3.8M) for a 2-year renewable Hong Kong residency, with Permanent Residency after 7+ years. Family included.

### 2. Property Investment Visa

- Invest HKD 30M in eligible Hong Kong property under CIES for a 2-year renewable visa. Permanent Residency after 7+ years. Family included.

### 2. Business Investment Visa

- Invest HKD 30M in CIES business for a 2-year visa; PR after 7+ years. Family included.

### 2. Securities & Fund Investment

- Invest HKD 30M in CIES securities/funds for a 2-year visa; PR after 7+ years. Family included.

## Process

- 1 Financial and eligibility assessment
- 2 Submission of residency application
- 3 Approval in principle
- 4 Make a qualifying investment
- 5 Receive a residency permit
- 6 Maintain investment and renew residency
- 7 Apply for PR after 7+ years of residence
