

## Investment Options

### 1. Real Estate Investment.

- Investors must acquire at least €250,000 in a National Bank of Hungary-registered real estate fund, with 40% of assets in residential property. Commercial investments are allowed but cannot replace the residential minimum. The investment must be held 5 years, managed only by licensed fund managers under a regulated policy.

### 2. Donation to a Public Trust

- Applicants may also qualify by making a non-refundable donation of at least €1 million to a Hungarian public trust institution of higher education serving public functions.

## Process

- 1 Prepare passports, proof of funds, income details, background checks, and dependent documents.
- 2 Submit Type D Guest Investor Visa at the nearest Hungarian Embassy/Consulate.
- 3 Authorities verify documents, funds, and background.
- 4 Receive 6-month Guest Investor Visa.
- 5 Receive renewable 10-year residence card for you and dependents.
- 6 Eligible citizenship after 8 years of continuous residence, language, and integration requirements.
- 7 Renew 10-year residence permit while maintaining compliance.
