- **Clean criminal record required; must pass background checks.**
- Proof of sufficient funds for the qualifying investment.
- Legally married spouse and children under 18 can be included as dependents.

## Investment Options

### 1. Business Investment

- Minimum €50,000 equity investment in a Latvian company. The company must employ fewer than 50 people, have an annual turnover under €10 million, and pay at least €40,000 in taxes annually.

### 2. Real Estate Investment

- Minimum €250,000 investment in real estate located in Latvia.

### 3. Special Purpose Bonds

- Minimum €250,000 investment in interest-free government bonds issued for special purposes.

### 4. Bank Deposit

- Minimum €250,000 investment in interest-free government bonds issued for special purposes.

## Process

- 1 Select a qualifying investment option : business, real estate, government bonds, or bank deposit.
- 2 Gather passport, proof of funds, police clearance, certificates, and insurance.
- 3 Undergo background verification by Latvian authorities.
- 4 Submit residence application to OCMA or Latvian embassy/consulate.
- 5 Attend biometric appointment and receive D-type visa.
- 6 Receive 5-year temporary residence permit.
- 7 Maintain investment and minimal physical presence.
- 8 Apply for permanent residency after 5 years; citizenship after 10 years with language and integration requirements.
