## About Malaysia RBI

A golden visa program called Malaysia My Second Home (MM2H) allows foreigners to live in Malaysia for an extended period of time. The program offers flexible terms for investors, retirees, and expatriates, catering to a variety of lifestyle needs with separate categories and eligibility requirements. Depending on the category chosen, MM2H offers a renewable visa with terms varying from five to twenty years. The applicant may withdraw up to half of this deposit specifically to purchase a home in Malaysia.

## Eligibility

- Minimum MYR 500,000 investment in an approved option
- Be 18+ years of age
- Show proof of a qualifying investment or stable income.
- No criminal history required.

## Key Benefits

- 20-year residency permit that can be renewed for an additional 20 years
- Live, work, and do business in Malaysia.
- Includes spouse, parents, parents-in-law, and unmarried children under 21.
- Only Malaysian income is taxed, with double taxation agreements.
- visa-free or visa-on-arrival access to a total of 183 countries and territories

## Investment Options

A specific amount must be deposited in a Malaysian bank for the duration of the visa for each of the three tiers that MM2H applicants can select from.

- Silver Tier: five-year term (renewable), MYR 500,000 deposit
- Gold Tier: 15-year term, renewable, deposit of MYR 2 million
- Platinum Tier: Permanent residency and a deposit of MYR 5 million

In each instance, up to half of the deposit may be taken out to cover expenses for home purchases, medical bills, or education. The minimum cost of a home must be MYR 1.5 million (Platinum) or MYR 750,000 (Silver and Gold tiers).

## Process

- 1 Submit MM2H or PVIP application to Malaysian Immigration.
- 2 Receive conditional approval letter for approved applicants.
- 3 Travel to Malaysia, open bank account, complete medical checks.
- 4 Submit bank and medical documents to Immigration.
- 5 Receive full approval from Immigration.
- 6 Applicant and family get long-term multiple-entry visas (MM2H: 10 yrs, PVIP: 20 yrs).
