## Investment Options

### 1. Lump-Sum Tax / "Forfait" Residency

- Wealthy individuals negotiate an annual tax based on living expenses rather than worldwide income.
- No business creation or employment is required.

### 2. Business / Entrepreneur Investment

- Setting up or investing in a Swiss company that contributes to the economy, often including job creation.
- Residency is granted based on economic benefit to the canton.

## Process

- 1 Select investment route: lump-sum tax or business/entrepreneurship.
- 2 Submit documents: proof of funds, clean criminal record, family details.
- 3 XIPHIAS preliminary due diligence to ensure compliance.
- 4 Cantonal review and approval of tax agreement or business investment.
- 5 Obtain Swiss visa (National D) and apply for residence permit with guidance.
- 6 Biometrics and permit issuance; annual renewal required.
- 7 Optional naturalization after 10 years with integration compliance.
