- Investors can secure a US Green Card by investing \$1,050,000 (non-TEA) or \$800,000 (TEA) and creating 10 full-time jobs. Spouse and unmarried children under 21 are included. This hands-on route offers potential returns and US residency, with a path to permanent Green Card and citizenship after five years. Investment is at risk until job creation requirements are met.

2. Regional Center EB-5

- Investors can passively get a US Green Card by investing \$800,000 (TEA) or \$1,050,000 (non-TEA) in a USCIS-approved project creating 10 jobs. Family included, with a path to permanent residency and citizenship. Investment is at risk until job creation is verified.

- 10 Apply for U.S. Citizenship (Optional)
